In order to comply with the laws of Kentucky and to maintain the integrity of the Nicholasville Farmers' Market, a detailed application is required. We value the time and effort that you will be spending in completing this application.

Your full completed application must be received and membership approved by the Nicholasville Farmers' Market Membership Committee at least 7 days before your first market day.

#### **Vendor Application Categories and Documents Required:**

**Farmer Vendor**: You are selling produce, plants, agriculture products grown on your farm.

- Use the farm Application which includes a Farm Plan (A best guess estimation with approximate harvest amounts.)
- Copy of approved labels and certificate if you are selling eggs or meat.
- Copy of Sampling Certificate if you plan to offer food samples. This certificate is required of each person giving samples at your vendor table.

**Value-Added Vendor:** You are selling processed farm products such as canned food, baked goods, jams and jellies, body products (soap, lotions, balms, etc) and/or pet treats.

- Use the farm application
- Copies of KDA, health department and /or other certificates
- List of all products to be sold.

**Prepared Food Vendors:** You are selling ready-to-eat food at the market.

- Farmers Market Temporary Food Service establishment permit or permits required by

• Sampling Certificate and Menus plan

Prepared Food Vendors must demonstrate a direct farm impact, offering menu items that contain ingredients sourced from local Kentucky farmers.

**Artisan Vendor:** You are selling hand crafted art/products that you created.
